SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. School Staff have consistently remained engaged with the Parents/Guardians, the ongoing communication has helped assess the needs and challenges a student and or a family may be feeling. School's summer sessions provided the staff to meet with the families and understand what was important to them. The primary themes indicatedte that the LEA should continue providing extra support to combat the loss of learning, create a safe building to support re-entry to full in-person learning, support the emotional and mental well-being of the students and families. The school administration team also recognized that it is important to all our stakeholders that the school continue to provide device to every student and helps maintain internet continuity.

Throughout the Pandemic the school has been measuring the student performance using the Star assessments. The students are screened three times a year, the results help identify needs, monitor progress, and guide instruction delivery accordingly. Our School Counselors and Social Workers have been engaged with the families, which has helped discern the needs related to social emotional well-being.

WCCS recognized the importance of these suggestions and created a plan to distribute the funding to cover as many of these areas as possible. The LEA weighed how to best address student needs, while also meeting the instructional priorities. The plan was reviewed from the point of view of supporting the needs even beyond the funding period.

WCCS is committed to maintaining transparencey and dialogue with all our stakeholders, by holding open meetings at least every six months, throughout the grant period everyone will have access to provide feedback via the above form. Our Administration team will continue to communicating with the parents at a regular frequency, the team will review and analyze the incoming feedback and be in a state to pivot as

WCCS will have a designated position responsible for establishing a curriculum and instruction plan. School will leverage multiple modes to measure student social and emotional needs, student progress in academics based on multiple checkpoints and assessments through the academic year. The school will have extended day and summer programs to support the unique needs of our students and families.

The LEA reviews the student attendance data, STAR assessments, track student behavioral issues. The school has also partnered with an math consultant who observes the staff in and provides them instructional coaching so they can best meet the needs of the students.

The LEA reviews the data from student management system weekly, there are reports run to track chronic absenteeism so our Pupil Services team can make interventions as needed. Student grade level performace is measured on an ongoing basis, which will provide a basis for understanding if additional staffing and instructional changes are helping a student improve or not. The school has hired Culture Officers to help transition the students to in-person learning, the LEA will be measuring the rates of discipline issues at the school.

Westminster Community Charter School will hire an Instructional Coach who will help oversee the unique needs created due to the pandemic. The school will also be hiring additional teachers to serve as co-teachers in high needs classrooms, so students are given individualized attention. The school will also be engaging tutoring services to provide additional intervention for the students.

The ARPA Grant funding will also be used towards providing Saturday School and Summer School Programs which will provide opportunities for enrichment and improvement of skills. The LEA will review the needs of the ELL populations and other high needs groups, and create instructional offerings based on that assessment. The participants grade level performance will be tracked pre and post attendance, to gauge the effectiveness of these measures.

WCCS is committed to supporting social and emotional wel being of the students and families, the school will be hiring a consultant to assist

Hiring of additional school social guidance counselor to provide academic, career and SEL services.

The school will utilize the funding to upgrade the classroom facilities by adding newer classroom equipment.

The school will be undertaking the project to replace the HVAC System.

WCCS is reviewing all curriculum and instructional programs for all the grades offered at the school, K-8, to ensure the needs of all our student body are understood and met. The school has expanded the Wit & Wisdom program. All grade levels will have a new ELA curriculum, accessibility to Renaissance STAR program to assist with Math assessments. And a strong coaching and professional development plan to support teachers. The school has hired a math coach to work with teachers and administrators at WCCS.

The LEA recognizes the unique needs of it's population, majority of the population is from low-income, with a variety of needs. School has a longstanding history of supporting not just the student but the family and the community as a whole. The LEA has community partnerships and staff in place to assist students of color, English Language Learners, McKinney Vento families, students with disabilities and any other high need constituency that may arise. Westmisnter has exapnded it's Wit and Wisdom program to train the staff to be on the lookout and triage student needs. The school Administrator and Business Operations Director met with a leader of the newly arriving immigrant community in the neighborhood, and shared with them how ARPA funding will help meet some of their raised needs. Such as additional instructional support, enrichment activities, hiring of diverse staff, and availability of devices.

- \$555,000: The school is dedicated to improving the indoor air quality of the School building, the grant will help support the replacement of the aging HVAC system. It will help support these three main work streams
